

3. Applicant applying for BANRF 2019 must have their Ph.D. Admission/Registration date on 1<sup>st</sup> January 2019 to 31<sup>st</sup> December 2019.
4. The Applicant who accepts or holds any paid appointment, full time, part time or receive Emoluments Salary, stipend, fellowship, business etc. from any other source during the tenure of the Ph.D will not be eligible for BANRF-2019.
5. Applicant who have already availed fellowship benefits from any other institute / university will not be eligible for BANRF-2019.

1. Selected candidates for Ph.D Fellowship, will be paid 31,000/- per month (JRF) for the initial two years and 35,000/- per month (SRF) for remaining period. (Subject to providing up-gradation certificate.)
2. Selected candidates are eligible to draw house rent allowance (HRA) & contingency as per government rules and regulations.

**Terms & Conditions:-**

1. All fellowship benefits of BANRF-2019 for selected candidates will be disbursed from the date of Registration/Joining to their universities/ Institute.
2. Eligible applicant can apply only through online application process for BANRF-2019. Offline application will not be entertained.
